#### Introduction

This statement is made on behalf of Composites One LLC, headquartered in Schaumburg, IL (USA), and its affiliated entities:

It is a priority to ensure that we trade ethically, source responsibly and work to prevent modern slavery and human trafficking throughout our organisation and in our supply chain. This statement highlights the key activities we have undertaken during this financial year to combat modern slavery in our organisation and supply chain, including implementing a Code of Conduct, communicating our Code of Conduct to all suppliers, and requiring suppliers in medium-high risk forced labour areas to sign a copy to confirm compliance with its terms, and rolling out our global "Ethico" ethics whistleblower hotline for all stakeholders.

# **Organisation's structure**

We are a leading provider of raw materials and process materials essential to composite manufacturing in the aerospace, construction, consumer recreation, cultured marble / solid surface, defence/ballistics, industrial/ corrosion, infrastructure, marine, process consumable, transportation, and wind energy/power industries. Composites One LLC and our affiliated entities have over 970 employees worldwide and operate in England, the USA, Italy, France, Brazil, Mexico and Canada.

# Our UK business

Our UK business operates through Aerovac Keighly Ltd and Aerovac Med-Lab Ltd, which are both subsidiaries of Aerovac Systems UK Ltd, which is itself a subsidiary of Aerovac Systems LLC (an affiliated entity of Composites One LLC).

# Our supply chains

Our supply chains include: The Procurement and distribution of both direct and indirect materials for the fabrication of composite components including the following: thermoset resins, gelcoats and epoxies; fiberglass and carbon fiber reinforcements, advanced materials such as pre-impregnated reinforcements, structural films, core, extruded films, process materials and equipment; and chemicals and consumables such as styrene, acetone, organic peroxides, mold releases, adhesives, abrasives, additives, fillers, personal protection equipment, masking tapes, surface finishing products and processing aids.

#### Our policies

We have appropriate policies in place that underpin our commitment to ensure that there is no modern slavery or human trafficking in our supply chains or in any part of our business. We continuously review and update all our policies.

# Supplier adherence to our values and ethics

We have zero tolerance to slavery and human trafficking. To ensure all those in our supply chain and contractors comply with our ethics, we have the following Due diligence policies and procedures in place to identify and address risks include the following:

- A Code of Conduct that sets out our ethical standards and expectations for our employees, suppliers, and partners.
- Terms and Conditions of Purchase and Distribution Agreements that require our suppliers to comply with all applicable laws and regulations.
- Supplier Screening and option to audit to evaluate the performance and compliance of a supplier with respect to various standards, regulations and contractual obligations and to verify supplier's sources of materials, subcontractors and workers.

- Government Compliance
- Human resources
- Product and Market Management
- Health, Safety and Environment
- Global Trade Compliance

# Training

To ensure a high level of understanding of the risks of modern slavery and human trafficking in our supply chains and our business, we provide annual training to our staff that work in areas at risk for modern slavery and human trafficking.
